

"I know what it is to be in need, and I know what it is to have plenty. I have learned the secret to being content in any and every situation, whether well fed or hungry, whether living in plenty or in want. I can do everything through him who gives me strength."

(Philippians 4:12, 13)

Paul's words to the Philippians serve as a fitting summary of Calvary's history during the 1990's. Throughout the decade the congregation faced a number of challenges. Some were major; others were lesser. But like Paul, Calvary learned the secret to being content and overcoming those challenges with Christ's strength. Consequently, challenges transformed into growth—sometimes physical, but always spiritual. In this brief summary of Calvary's congregational minutes (1990's), Christ's strength is evident in all areas of congregational life. From budgets to buildings, workers to worship, edification to adaptation, Christ strengthened Calvary Lutheran Church through with his loving kindness.


Calvary experiences growth

Physical Growth

Throughout the 1990's, Calvary's congregational minutes record steady growth in membership. From the beginning of 1991 to the end of 1999, the Lord added over 100 souls to Calvary. Numbers are never the sole indicator of the Gospel's success. However, when the Lord chooses to bless a congregation with growth in numbers, he is to be praised. Through faithful administration of Word and Sacraments, the Lord blessed Calvary with noticeable physical growth. And, as it will be expounded below, Calvary's physical growth led to challenge and change in other areas of congregational life.

Spiritual Growth

Far more important in God's Church is *spiritual* growth. The strengthening of faith is the ultimate purpose and goal of every Christian congregation. Calvary Lutheran Church is no exception. From adult discipleship to childhood education, Calvary expanded its programs to meet the true needs of its growing membership.

Sunday School has always been a chief tool for Calvary to instruct its youth in the Christian faith. A glance at the comparison of numbers from the beginning to the end of the 1990's shows what a useful tool Sunday School was. Calvary's Sunday School reached a considerable number of children throughout the decade. In February of 1991, the Sunday School Coordinator reported an enrollment of 40 students.² The enrollment more than doubled by the end of the 1997-1998 school year. The coordinator reported an enrollment of 97 children.³ By the end of the 1990's, nearly 100 children had the weekly opportunity to grow in their faith by studying the Word of God in Sunday School.

Calvary also utilized an annual Vacation Bible School program to provide opportunities of spiritual growth. Through Vacation Bible School, Calvary was also able to reach out to the community with the Gospel of Christ. Once again, the number of children attending over the course of the decade more than doubled. In 1990 there were 55 children who had attended Calvary's Vacation Bible School. By 1998 there were 111 students who had attended. What a wonderful blessing to reach out to children with the Good News.

Spiritual growth was not limited to Calvary's children. Opportunities for Adult discipleship also expanded. In addition to its regular Sunday morning Bible class, Calvary added a number of mid-week Bible studies.⁶ This demonstrated Calvary's commitment to spiritual growth. These additional classes took into consideration the changing schedules and demographic of the congregation. There were more opportunities to get more of the Gospel to more people.

Calvary continued to recognize its need to provide for the spiritual growth of its adult members. In 1995, Calvary initiated an adult discipleship program. The program was titled, "From Age to Age." This program allowed the congregation to address the many areas of spiritual growth—from worship to Bible class.

Aside from its called workers, the elders of the congregation are directly involved with the spiritual growth of its members. Calvary recognized this in a unique way in the 1990's. Beginning in 1992, Calvary's elders began to structure themselves into what they called, "District Elders." After dividing the Thiensville area into twelve districts, the congregation

called an elder to be responsible for the people in each district. Whether to members or non-members, each District Elder could devote his attention to spiritual growth in that area.

From youth to adult discipleship, Calvary demonstrated innovation and love in carrying out the great commission among its people. They spread the Gospel and trusted that God would keep his promise to accomplish his Will through it.

Calvary educates its youth

True to its Lutheran roots, Calvary was as committed as ever to providing a strong education through its own elementary school. The 1990's saw the Lord's tremendous blessing on its Lutheran Elementary School. They were years of great expansion for Calvary Lutheran School. It expanded its enrollment, called workers, and facilities.

Enrollment

At the beginning of the decade Calvary Lutheran School had an enrollment just under 100. The beginning of the 1992-1993 school year reported 98 students. For a Lutheran Elementary School that is a substantial number of students. However, as a common name for private schools suggests, viewing 100 students as a large number turned out to be rather parochial. In five short years that number would increase by more than 50%. In May of 1997, the principal projected the 1997-1998 enrollment to reach 160 students.

Called Workers (Teachers)

Throughout the 1990's, Calvary Lutheran School saw a number of different teachers in its classrooms. In all, there were 1th full-time teachers and 3 part-time teachers that served Calvary:

Whenever Calvary was challenged with a vacancy, the remaining teachers pulled together to meet that challenge until the Lord provided another worker. Calvary's many teachers provided proof that the Lord keeps his promise to send workers into his harvest field. May he continue to bless Calvary with faithful workers.

Facilities

Aside from the amount of teachers, the growing enrollment throughout the 1990's provided its own challenges. Numbers expanding beyond 100 stretched the limits of the school building. Four school rooms were just not sufficient for that many students. Consequently, in 1994, the voters' assembly passed a motion to expand the school facilities:

A motion was made and seconded that the congregation approve the proposed building expansion plan with an estimated cost of \$850,000.00. There was a lengthy period of discussion in which all present were permitted to ask questions or make comments. The architects of the expansion project from Thern Design Center, Inc. were present to

answer questions... The motion to approve the building expansion plan passed by a margin of 55 to 7 with 1 abstention. 13

That was a sizeable leap of faith, considering the congregation's budget challenges. (The budget will be examined below). It was a leap that was to stretch even farther in 1995. The final cost would be \$1,025,000. The voters were again willing to do what it took to expand their school.

Ground was broken later in 1995. 14

Calvary adapts to challenges


Challenges test the true character of a person. It seems to do the same for congregations. The 1980's seemed to be a smooth decade for Calvary. For the most part, they were blessed with stability—in their finances and their worship life. The 1990's, however, presented unique, sometimes difficult challenges for Calvary. Calvary learned what it was like to be in want. Calvary learned what it was like to face changing culture. But above all, Calvary learned how to be content and overcome challenges through Christ's strength.


Budget Challenges

Through the end of the 1980's Calvary's budget was in the black. The 1990's, however, were a different story. After 1991, Calvary's budget dipped into the red. Without thorough documentation, Calvary's budget seemed to stay in the red throughout the decade. Nevertheless, the Lord blessed Calvary's ministry and stewardship during those years. The following graphs demonstrate Calvary's budget challenges:

Numbers can represent a variety of things. It's obvious, however, that there were major changes and challenges within the 1990's budgets. First, the operating budget dropped dramatically between 1993 and 1995. Second, as a result, the general fund kept falling short of its budgeted amount. Apart from an occasional remark about poor stewardship, the causes of

these changes were not discussed within the congregational minutes. Therefore any discussion of cause would be uneducated speculation.

Despite these challenges, ministry at Calvary needed to go on. Calvary used various strategies to accomplish this. They borrowed money from members at a reduced interest rate. They carefully studied stewardship principles. The most interesting strategy, however, was the purchase of some property north of the church building. This property had office spaces to rent out. Through these rentals, Calvary was able to help out the budget crisis, as well as have needed land for future expansion.

It is obvious that the Lord blessed Calvary's ministry throughout the budget shortfalls. First, they were able to expand their school facility in the year with the lowest operating budget. Along with the school expansion project came a parking lot expansion for \$35,000 and refurbishing the kitchen for \$11,700. Calvary recognized the need for growth, regardless of obstacles.

Second, they were able to start climbing out of debt. Through their wise and shrewd financing, the Lord blessed Calvary to be nearly in the black by the end of the decade.

Worship Changes

In Acts 6, Luke records how God gives his Church freedom to carry out ministry in an efficient and effective way.

In those days when the number of disciples was increasing, the Grecian Jews among them complained against the Hebraic Jews because their widows were being overlooked in the daily distribution of food. ² So the Twelve gathered all the disciples together and said, "It would not be right for us to neglect the ministry of the word of God in order to wait on tables. ³ Brothers, choose seven men from among you who are known to be full of the Spirit and wisdom. We will turn this responsibility over to them ⁴ and will give our attention to prayer and the ministry of the word" (Acts 6:1-4).

When Calvary's numbers were increasing, the congregation recognized it needed to adapt ministry (not doctrine) to serve effectively. When worship was at near capacity during festival services, Calvary adapted. The voters passed motions to continue Thursday services, as well as add an additional service at Christmas, Easter, and Thanksgiving.¹⁶

More than time was to change Calvary's worship in the 1990's, however. Variety and a richness of worship came with the new hymnal of the Wisconsin Evangelical Lutheran Synod. *Christian Worship: A Lutheran Hymnal* was introduced rather quickly after its release:

After thorough and faithful explanation and discussion by many of the voters a motion was made seconded and passed by a majority vote that Calvary Congregation purchase and incorporate the Christian Worship for Lutheran Congregations, our Synod's revised hymnal, to replace our existing hymnals. The council was authorized to purchase 350 of these hymnals and directed to have them in place by the start of the new church year beginning December, 1993. The council and Pastor were also directed to introduce the revised hymnal in such a fashion as to promote the smoothest transition possible from the old hymnal to the new hymnal.

After the voters had discussed the matter, the motion was called the vote taken and the motion passed, Mr. Netz requested that the secretary record in the minutes that this decision was made without having first seen the new/revised hymnal. The voters took no action on this request and no further discussion was held.¹⁷

Along with a new hymnal came a couple of other worship changes. Worship cards, containing the outline of the service, were introduced for easy participation in worship. These seemed to have worked well. The voters' assembly passed a motion to make them permanent in 1995.

The Lord's Prayer was the another change. The contemporary version was introduced slowly in 1995. Eventually it became the only version used.¹⁸

Finally, Calvary's growing membership grew in its appreciation for the Lord's Supper.

The congregation purchased the communion ware for individual cups in 1991. With that change

they eventually added elders and council members as communion assistants. Calvary's adaptations didn't stop there. In 1996, the voters discussed having communion in one service every Sunday:

It was suggested that the elders review the idea of varying the communion schedule from the current practice of using the first and third weekends of the month. There may be conflicts for those who work some weekends during the month and that having communion during at least one service each week should be considered. ¹⁹

Again, these are beautiful examples of expanding ministry to serve the needs of God's people.

The 1990's were a decade of changes and challenges for Calvary Lutheran Church. But God was faithful to his flock in Thiensville, Wisconsin. He provided leaders full of the Spirit and wisdom. Through their loving leadership, the Lord blessed Calvary to overcome its challenges and adapt to the changes. Through times of plenty and times of want, through every situation, the Lord built up his people. During the 1990's, Calvary Lutheran Church did everything through Christ, who gave them the strength.

Annual Voters Meeting February 18, 1991 7:05 PM

Attendance: 28

I. Opening

The meeting was called to order by President Rae Schumacher at 7:05 PM. Pastor Scheuerlein opened the meeting with a reading from the book of Joshua. Pastor concluded his devotion with a prayer.

II. Previous Meeting Minutes

Minutes of the previous voters meeting of December 17, 1990 were read and approved.

III. Membership Changes

IV. Reports

Pastor:

Pastor Scheuerlein reviewed congregation statistics and explained why figures dropped when we had an actual increase, because of possible baptisms etc. which were included through the years in numbers but were not members.

Principal:

Report as submitted in Annual Report. Principal Zastrow highlighted addition of Mrs. Gehrke as extended learning teacher serving 7 students and that Mrs. Tiefel's student count for piano lessons was growing. Also, junior handbells increased from 8 to 12 students.

Christian Education Society:

Dennis Mastin highlighted the meeting schedule and the fact that we had a successful fund-raising campaign which received matching grants from benevolent organizations, notably AAL and Lutheran Brotherhood. Balance of information is in the Annual Report.

Church Council:

Tom Nass highlighted the year of 1990:

- Flynn house was torn down and off the tax roll
- Individual communion cup ware was purchased and begun
- Hand rails were purchased and installed
- Mail boxes were built and installed
- Congregation was \$900.89 ahead at the end of the year

Ladies Auxiliary:

Besides the report in the Annual Report, Pastor encouraged everyone to help by supporting and encouraging all women of the congregation to join.

Young Peoples Society:

It was reported that Tom and Diane Nass were very instrumental in the success of the program.

Vacation Bible School:

Pastor reported that we had 55 students in 1990. Mrs. Peggy Mc Allister will again coordinate the VBS in 1991. Program will be used as a mission outreach program to encourage the children to grow with their Savior.

Sunday School:

Pastor Scheuerlein reported that four of the teachers are new members to Calvary in the last year. Approximately 40 students have attended on Sundays.

Evangelism:

Pastor highlighted that our own members are the best evangelizers we have. More people are joining because members are spreading the Good News.

Church Teams:

Pastor reported that the dartball team could always use more members.

Kettle Moraine Lutheran High School:

Ron Klemann highlighted that we have excellent staff and students. We need more financial support, however, for the high school.

Wisconsin Lutheran High School:

WLHS is looking for enrollment increases in the next few years to approximately 950. Problems are: still trying to keep tuition at a reasonable level and to get more financial commitment from congregations.

Wisconsin Lutheran College:

Rae Schumacher highlighted:

- Accreditation as a four-year liberal arts college is for a length of seven years. The seven years is more that the staff and faculty had hoped for.
- The school has received final approval to build a new recreation/activity center. Building is being downsized slightly to add parking under the gym.
- Carroll Dummann reported that at the last moment the Wauwatosa city council voted favorably due to one member showing up for the vote in a wheel chair.

Treasurer's Report:

We ended the year \$900.89 in the black. However, we started 1990 with a \$3291.59 cash balance, so disbursements overall exceeded receipts for the year.

Financial Secretary:

Rae Schumacher reported that the Treasurer's report and the Financial Secretary's report balance and that the Financial Secretary's report lists actual receipts by category.

A committee was established to review Pastor Lindloff Scholarship Fund mechanics for disbarment, how to apply, etc. Recommendation will be forthcoming in a future congregation meeting.

VI. Old Business

VII. New Business

• A motion was made and seconded that "due to the enlarged enrollment and the need for assistance in other academic areas of our church and school, the called position of kindergarten teacher in our Christian Day School be made a full-time position beginning with the 1991-1992 school year."

Mr. Zaferos suggested that we again explore the option to work out a program with St. John's to consolidate programs and be able to absorb St. John's teaching staff.

Mr. Zastrow reported that we have 12-14 mothers who come in to help the teachers.

After discussion, motion passed.

• A motion was made and seconded that "with the announced retirement from teaching of Mrs. Lois Balge, our congregation request a call list from our district president for a full-time kindergarten teacher with abilities in music and/or art."

After discussion, motion passed.

It was announced that we would have a call meeting in the next couple of weeks and that it would be announced in the bulletin.

• A motion was made and seconded that "Calvary congregation commit a pledge of \$10,000 total over the next three years to the 'Continuing in His Care' building fund debt reduction program of Kettle Moraine Lutheran High School."

After discussion, motion passed.

• A motion was made and seconded that "in order to permit Pastor Scheuerlein to attend the Board of Directors meeting at Kettle Moraine Lutheran High School, that our congregational meetings be moved to the fourth Monday of the designated months."

After brief discussion, motion passed.

The meeting was called to order by the President at 7:00 P.M. and was opened with prayer by Pastor.

II. PREVIOUS MEETING MINUTES

Much discussion relative to the current cash needs of the congregation was held. No motions were offered. The Stewardship program was discussed and it was explained that George M. Zaferos will address the congregation on relative to the current needs speaking in positive terms.

IV. MEMBERSHIP CHANGES

The membership changes were accepted as submitted with one addition for Mr. Peter Zalinski

V. REPORTS

SCHOOL BOARD

The SCHOOL BOARD reported that the school year started well. They are examining position descriptions for the called workers and are working on a worker care committee, a non-WELS program and a Team Ministry program.

TRUSTEES

The TRUSTEE'S reported work activities on heating and cooling plants, the garage roof of the parsonage, the storage building, lighting needs of the church property and the broken church light fixture.

ELDERS

The ELDERS presented the districting program in detail. A motion was made seconded and passed unanimously to support this program. It was recommended that the Elders seek volunteers for the District Elder positions through the church newsletter.

PRINCIPAL

The PRINCIPAL reported that the school year is off to a good start. There are 98 students which is the highest enrollment in 5 years. However, this only amounts to 76% of the eligible children of the congregation. Many of the 24% who are not attending Calvary School are in 5th grade or higher, had started in public school and now wish to remain in public school for continuity purposes.

The damage to the school gymnasium windows has been paid by the responsible parties. The kindergarten and first/second grade teachers with the assistance of the teacher aids have worked out a satisfactory program to address the large class size in those rooms.

Mr. Zastrow was asked if any discipline problems existed in the school. He explained that there is some sin which needs correcting but there is limited behavior difficulties. Mrs. Gehrke the extended learning teacher resigned to accept a different position which is most beneficial to her responsibilities to her family. This resignation occurred on positive terms as she was being paid for 2-3 hours work per week and her new position will provide as many as 32 hours per week. The schools needs in this regard are being studied and a recommendation will be forthcoming.

PASTOR

The PASTOR reported: 1. The Sunday School Superintendent (Miss Fisher) is doing an excellent job and the entire program is going very well. Attendance in Sunday School is up, there is a well attended teen Bible class, the adult Bible class has 80-90 regular attendee's and the mid-week Bible classes are expanding.

There will be no special reformation service and there will be two (2) Thanksgiving services. Pastor listed those members who were sick, at nursing homes or who otherwise may need special assistance or care. A youth ministry program is also being initiated.

ASSOCIATIONS and AFFILIATIONS

1. The Wisconsin Lutheran College recreation center was dedicated on September 12, 1992. The current enrollment is 326. They expect to reach 450. There are two new faculty

members. They are expecting a \$25 million endowment and will build a new fine arts building. They recently bought three apartment buildings to use as dormitories

- 2. Wisconsin Lutheran Child and Family Service is looking for a new administrator for their nursing home.
- 3. Enrollment is high (270). They are planning to expand. They are still calling a religion instructor.
- 4. Wisconsin Institutional Ministries is expanding.

MISCELLANEOUS

The President announced that the Stewardship Committee had met and presented their program in detail. The planning committee was released with each member being publicly thanked for his service. A new committee was appointed. The special mission envelope was thoroughly discussed and no plans for a mission festival Sunday have been made.

The council was authorized to purchase 350 of these hymnals and directed to have them in place by the start of the new church year beginning December, 1993. The council and Pastor were also directed to introduce the revised hymnal in such a fashion as to promote the smoothest transition possible from the old hymnal to the new hymnal.

II. PREVIOUS MEETING MINUTES

The minutes of the 12/19/94 meeting were read. A correction was made to Pastor's report that there have only been three funerals to date and a motion passed to accept the minutes as corrected. A motion passed to approve the meeting agenda as presented

A good deal of work needs to be done to prepare financial statements and applications to obtain the needed financing. Our congregation needs to show that we are both meeting and capable of meeting our current and anticipated financial obligations in all of our accounts.

VI. OLD BUSINESS

A. Purchase of the Property to the North - The closing date for the purchase of the property will be set by the bank when the documentation approving the environmental clean-up is received from the State DNR. The documents are expected to arrive very soon. Some work also needs to be done on the leases.

- B. Building Program Update We need too obtain a building permit from the Village. This takes at least 10 days. Assuming the permit is obtained in this time frame, construction could begin immediately following receipt of the permit. The building construction contract will be on a cost plus basis with a not to exceed amount established based on the total bid price. Cost savings below the not to exceed price will be shared with 75 percent of the savings going to Calvary and 25% of the savings going to the general contractor, James Luterbach Construction Co., Inc. School will close for the year on May 26th, one week earlier than scheduled. The existing classrooms and gymnasium will be ready for occupancy on or about September 5th for the start of classes. Construction will be completed around the last part of October. The gym floor will be installed within about two to three weeks after the gym is vacated. The kindergarten and the 7-8th grade class will meet in the gym during the first quarter next year. Vacation Bible School will not be held at Calvary during the construction period.
- C. A summary of the Self Study was presented including a list of the actions taken by the Council since completion of the self study project. Copies of the Self Study committee books will be available in the church library for those who wish to review them or check them out.

VII. REPORTS
