Our cover picture might well be titled "World Mission Work at Home." Pastor Paul Kolander, reporter for the Northern Wisconsin District, writes: "The members of Martin Luther Ev. Lutheran Church at Neenah, Wisconsin, witnessed a unique confirmation on Palm Sunday. Confirmed with the children's confirmation class were seven adults, of whom four were baptized in the service by the pastor, G. Jerome Albrecht. Of the seven adults, one is an American Indian, another a Vietnam veteran, and two are from the Republic of Gambia, West Africa.

"The two from West Africa, Baboucarr Nyang and Alieu Fofana, are students at the Fox Valley Lutheran High School in Appleton. These young men, who come from a Moslem background, heard about this school through a Peace Corps worker in their native land. After corresponding with the principal, Pastor Harold Warnke, arrangements were made for their enrollment. They hope to complete their high-school education at Fox Valley and then to go on to college in this country before returning to Gambia.

Heartening is the stand voiced by President J. Preus of The Lutheran Church - Missouri Synod in the Lutheran Witness Reporter, issue of May 16. We quote: "We must not take the position that all subjects not dealt with specifically in the Lutheran Confessions are thereby open questions. If the Bible speaks clearly - and it is a clear book - whether the subiect is dealt with in the Lutheran Confessions or not, it is something which we accept. We must avoid the danger of making the touchstone of orthodoxy merely the Gospel - as if when something does not violate the Gospel, it thereby becomes an open question. The rule in Lutheranism is not solum Evangelium (the Gospel alone) but sola Scriptura (Scripture alone)." We heartily agree with this statement of Dr. Preus. This has consistently been the position of our own Synod. We pray that this principle may find wholehearted acceptance at Missouri's convention. That would be of great help in solving many of Missouri's other problems.

Did you know that THIS WE BE-LIEVE, our Synod's Statement of Belief, has appeared in six languages besides English. It was first translated into Spanish and called EN ESTO CREEMOS. Using this translation are our Spanish-speaking congregations in Mexico, Puerto Rico, and the southwestern United States. In 1970, The Chinese Evangelical Lutheran Church printed 5,000 bilingual copies - English and Chinese - for use in Hong Kong and Taiwan. Pastor T. Paul Mitra has translated it into the Telugu dialect for his people in the Madras area of India. Just this year the statement was translated into French and given the title CE QUE NOUS CROYONS. It was printed in France by the Evangelical Lutheran Synod of France and Belgium. Presently it is also being translated into Norwegian.

This little booklet, by the grace of God, has been instrumental in making our doctrinal position better known to those outside our Synod. It reveals that the doctrinal position of our Synod is thoroughly Scriptural. Use THIS WE BELIEVE as a mission tool to acquaint others with the Gospel message.

"Lean Not Unto Thine Own Understanding" The chairman of the department of psychiatry at the University of California medical

school, Dr. Louis J. West, addressing the convention of the American Psychiatric Association, described how attempts by young people to find their own way in life have degenerated into hippie pads and communes. He is quoted in the press as saying: "The original 'flower children' flocked by the thousands to the Haight-Asbury District in San Francisco to find what they thought would be a more humane way of life. However, their dream of Utopia did not last very long. Haight-Asbury soon was invaded by underworld characters, attracted by the availability of illicit drugs and sex."

Thus ended another of man's noble experiments. It is one of a long list of failures on the part of man to find happiness and fulfillment by his own devices. These failures are not confined to programs developed by idealistic but immature youth. They are peculiar to all godless attempts to save the human race.

Education, for example, has been hailed as the salvation of mankind; but it has not resulted in a world of happy citizens, free of worry and full of love. Centers of culture are turning into fearsome jungles, and man has not been educated out of such terrors as selfishness, violence, and death. Science-technology, revered as the Messiah and bringing with it vast improvements in living standards, with two cars in nearly every garage—plus, in many cases, a boat—has not solved our problems either, but has rather of late been met with a growing disgust, especially on the part of the younger generation, because of the materialism which it engenders. A succession of ingenious cures has failed to cure; and uncertainty, fear, and despair are still as much in evidence as they ever were.

Relevant to this frustrating situation is a Biblical proverb, which reads: "Trust in the Lord with all thy heart, and lean not unto thine own understanding." This identifies both the reason for man's continuing failures and the specific formula for success.

"Here Comes the Bride" Is Out the most unlikely of times to issue a pronouncement in favor of conservatism in liturgy. Almost every church group is experimenting with liturgy. It might even seem to be the most unlikely of voices to utter such a pronouncement after a turbulent decade, but there it is—"'Here Comes the Bride' is out in Catholic churches from now on." The Vatican's Department of Divine Worship has advised that this and other popular wedding music should be replaced by something more sacred. It deplores "certain profane music during wedding ceremonies, which has been introduced by custom, but which hardly conforms to the spirit of the liturgy."

Even "Ave Maria," which is frequently sung at Catholic weddings and baptisms, has been declared unconsecrated. To our Protestant way of thinking, such an embargo is almost tantamount to banning "A Mighty Fortress" in Lutheran churches on Reformation Sunday.

It's not that the Catholic church is averse to any kind of change in its liturgy. New forms of music are being considered for their worship services. But its Department of Divine Worship is upholding the principle that our pastors have contended for when they gently or firmly tried to persuade the bride and her mother that "Largo" and "I Love You Truly" were out of tune with our liturgy and worship.

The profane and the worldly do not belong in our Christian worship services. If we make changes in our liturgy, the profane and worldly should be kept outside.

"Preaching Up the Times" "The Clergy Conference has endorsed fluoridation," the

Immoral? Somehow you suddenly felt left with the same "trumped" feeling you had when you explained to the salesman that you wouldn't endorse his \$34 Bible because your parishioners had sense enough to make up their own minds about his merchandise. "You're against the Bible," he said.

It could be that today's enlightened clergy are expert in the odontology, chemistry, medicine and politics of the fluoridation issue. Possibly they have insights available to no one else on earth.

But frankly, can you picture the Apostle Paul barnstorming around the seacoast cities of the Mediterranean crusading for "fewer cavities"? Can you visualize John on Jordan's banks thundering, "Fluoridate or perish," or, "Transport Samaritan children into your synagogue schools," or "Caesar, send the troops home"?

It is an old game, always intoxicating, to substitute "the critical issues of our times" for the promises of God that never fail.

Three centuries ago the Scottish Covenanters were fighting for religious freedom. People's passions were fired to a white heat. One stood aloof from it all. His colleagues asked Robert Leighton why he didn't "preach up the times." "Who does?" he asked. "We all do," they answered.

"Then," said Leighton, "if you are all busy preaching up the times, you will forgive one poor brother for preaching up Christ Jesus and His eternity."

Blood and Fire and Smoke!

"And I will show wonders in the heavens and in the earth, blood and fire and pillars of smoke.

"The sun shall be turned into darkness, and the moon into blood, before the great and the terrible day of the Lord come.

"And it shall come to pass that whosoever shall call on the name of the Lord shall be delivered; for in Mount Zion and in Jerusalem shall be deliverance, as the Lord hath said, and in the remnant whom the Lord shall call" (Joel 2:30-32).

What a glorious prospect was held before the Hebrews of Joel's day! There would come a time when the special outpouring of the Lord's Spirit would prompt a profusion of prophesying professions by all sorts and conditions of the children of men. From Pentecost to the Lord's Day the Spirit's shower would fall.

How Long?

When would the delightful deluge from God's Spirit begin? Joel prophesied: When the promised Teacher of Righteousness appears. Consequently, "all flesh" would be inundated with spiritual gifts from above. How long would the downpour last? When would it end? The answer, strange as it may seem, was the same: When the Promised One appears.

What undoubtedly did not occur to the people of Joel's time was the dual appearance of the Sun of Righteousness and the interval in between. Since Joel's prophecy wove together features both of His first advent and of His second coming, the people of Judah hardly could have conceived of a period lasting centuries, to say nothing of millennia. But we can, since we are living in the period between Christ's two advents.

God's Sign Language

The wonders and signs both in the heavens and in the earth attending the outpouring of the Holy Spirit obviously belong to the end of the period. Awful calamities on earth—bloodshed, destruction by fire, and earthly elements going up in smoke—betray the change-and-decay character of the world. They are harbingers of the dissolution of all human associations and of all material compositions. Everything that is transistory has an end.

Also ushering in the end of the universe are the wonders and signs in the heavens. This fact is corroborated by Christ Himself: "Immediately after the tribulations of those days shall the sun be darkened and the moon shall not give her light and the stars shall fall from heaven and the powers of the heavens shall be shaken" (Matt. 24:29).

The end of all things will be accomplished at the appearing of the Son of Man, who "shall come to judge the quick and the dead." Judgment belongs to the era of the Spirit, as Jesus testifies: "And when He (the Comforter) is come, He will reprove the world of sin and of righteousness and of judgment: of sin, because they believe not on Me; of righteousness, because I go to My Father, and ye see Me no more; of judgment, because the prince of this world is judged" (John 16:8-11).

Your Name and His

Against the background of Judgment Day, "the great and the terrible

day of the Lord," the blessed work of the Holy Spirit must be viewed. Will anyone be delivered from death and destruction? If so, who will escape the terrors of that day? How will they reach safety? Is there any hope of deliverance for us?

The people of Joel's day were not left in the dark about these vital questions. Neither are we. "It shall come to pass that whosoever (insert your name!) shall call on the name of the Lord shall be delivered." "For there is no difference between the Jew and the Greek, for the same Lord over all is rich unto all that call upon Him. For, whosoever (insert your name again!) shall call upon the name of the Lord shall be saved" (Rom. 10:12, 13). Heed the conclusion of Peter's Pentecost sermon on Joel's text: "Repent and be baptized every one of you in the name of Jesus Christ for the remission of sins and ye shall receive the gift of the Holy Ghost. For the promise is unto you and to your children and to all that are afar off, even as many as the Lord our God shall call" (Acts 2:38,

The "remnant," the few chosen of the many called, still are a multitude of nations that have been gathered on "Mount Zion" (Rev. 14:1), the "Jerusalem" that is the "Holy Christian Church, the communion of saints." But only those who call on the name of the Lord, "the remnant," shall be saved. "Neither is there salvation in any other, for there is none other name under heaven given among men whereby we must be saved" (Acts 4:12).

"It shall come to pass . . . !" That is the Lord's promise. It cannot be broken!

Its Origins

When Michael Servetus (1511-1553), a Catholic law student from Spain, saw the people kiss the Pope's feet, he is said to have exclaimed: "Oh, beast of beasts, the most wicked. The most shameless of harlots." His rejection of the Pope stemmed from the fact that he considered the theology of the ecumenical creeds as incomprehensible, especially the doctrine of the Trinity. He felt Luther should have discarded this doctrine as having no basis in the Bible. In fact, Servetus called it "blasphemy," a doctrine on account of which "not only Mohammedans and Hebrews, but the very beasts of the field would make fun of us did they grasp our fantastical notion, for all the works of the Lord bless the one God."

On October 27, 1553, Servetus was burned at the stake in Geneva. But that action did not put an end to all denial of the doctrine of the Trinity. In 1579, an Italian by the name of Faustus Socinus arrived in Transylvania and became the grand architect of Unitarianism. He went further in his denials than all those who preceded him, teaching that Christ was a mere man and that He was the Savior only by setting an example and not by dying as a ransom for men.

Present-Day Denials of Original Sin and the Resurrection

Present-day Unitarianism has even gone beyond Servetus and Socinus. Already in the last century its leaders were saying: "The cornerstone of Christianity is faith in Christ. The cornerstone of Free Religion (Unitarianism) is faith in human nature." Trust in human nature and a belief in its potential for good are the dominant characteristics or hallmarks of modern Unitarianism. Unitarians affirm: "The concept of original sin and the doctrine that man has to be saved from the consequences of that sin are utterly foreign to the thinking of religious liberals. Salvation by character - the conviction that our hope lies in the maturation of man and the continuing improvement of society - is at once their faith and their aim." And while a few believe in an immortality of the spirit, or believe that something uniquely and

distinctively personal does survive the fact of death, "it seems safe to say that no Unitarian Universalists believe in a resurrection of the body, a literal heaven or hell, or any kind of eternal punishment." (Cited from Unitarian Universalism: Some Questions Answered, by W. Argow.)

God's Word and Even God Discarded

The pamphlet just referred to also states: "The Unitarian Universalist attitude toward the Bible is that of almost all educated, informed people. . . . A wonderfully human document, the Bible is to them a record of man's unending search for meaning in the universe." According to a survey conducted a few years ago only 3 per cent of the Unitarian Universalists think that God is a supernatural being; 23 per cent believe that He is the ground of being, real, but not describable; 44 per cent think that God really consists of the processes of nature; and 28 per cent that it is too irrelevant a concept to be concerned about. Two per cent even felt that the idea of God was harmful.

An Expanding and Dangerous Cult

The most recent development in the history of this philosophical association took place in 1961 when the Unitarians (who had in the past objected especially to the Trinity) merged with the Universalists (who had especially objected to the doctrines of election and eternal damnation). By this time both of these groups were completely committed to faith in human nature and life in this world. This humanism of the Unitarian Universalist Association is gaining many new adherents for it. According to the statistics given in the 1971 edition of The World Almanac,

there are 282,307 members. This is a 58 per cent increase in membership during the past 10 years, a rate of growth second only to that of the Mormons and even ahead of the Jehovah Witnesses.

Not only is this Association growing rapidly, but it also cannot be denied that its membership can boast a large proportion of intelligent, influential people. According to the same recent survey, 63 per cent are professional people, 25 per cent have graduate degrees, and virtually all live in towns or cities. Unitarian Universalists represent nearly one-fourth of the names appearing in the American Hall of Fame and appear proportionately more often in "Who's Who" than members of any other religious group. They are greatly interested in winning the youth, as indicated by their statement: "The fastest growing part of most liberal churches and fellowships is their church school." They look upon themselves as the answer to today's needs, asserting: "In terms of intellectual honesty, devotion to objective truth, concern for character, faith in the human potential, dedication to social welfare and to the imperative cause of a world united in brotherhood and peace, Unitarian Universalism stands as the religious movement best suited to meet the Promethean demands of today and tomorrow's society."

Lest we be misled, it is well for us to contrast their statement: "The calibre of a movement can be judged by the kind of men and women who give their devotion to it," with the words of Paul in I Corinthians 1:26: "For ye see your calling, brethren, how that not many wise men after the flesh . . . are called." In the Church we do not glory in our intellectualism, but in the Word of God by which are cast down "imaginations and every high thing that exalteth itself against the knowledge of God" (II Cor. 10:5). May we who have the truth of God's Word continue to proclaim it with greater missionary zeal in our churches, in our church schools, in our communities! The God whom we preach is the one, true God in whom alone there is salvation for men.

WELS APPOINTS SIXTH CIVILIAN CHAPLAIN

The Rev. Karl J. Otto, pastor of St. John's Lutheran Church, Wauwatosa, Wisconsin, has been granted a year's leave of absence by his congregation to serve as a civilian chaplain of the Wisconsin Ev. Lutheran Synod in Vietnam. Pastor Otto is the sixth pastor to receive a leave of absence from his parish to serve in this capacity.


About August 1 Pastor Otto will leave for Saigon for several weeks of orientation with the present civilian chaplain, the Rev. Roland Ehlke, who is scheduled to return September 1. Even though troop withdrawal from Vietnam has made the civilian chaplaincy more difficult, the present chaplain has recommended that it be continued. He recently reported to the Synod's Military Services Committee that "we still have a ministry here to serve our men in the Armed Forces." WELS has had a civilian chaplain in Vietnam since December 1965.

Like his predecessors, Pastor Otto will set up his headquarters in Saigon, holding services there and "circuit riding" the other military bases and hospitals in Vietnam and Thailand, where about 500 Wisconsin Synod members are stationed. All WELS civilian chaplains have received fine cooperation from the Armed Forces. Without the assistance of the military they could not carry on their work. This type of assistance is necessary for any civilian to move in these areas - whether he is a war correspondent or a United States senator.

ST. MARK'S, WATERTOWN, WISCONSIN



St. Mark's of Watertown, Wisconsin, has the distinction of being one of relatively few congregations in our Synod known to almost all of its pastors. Many of them worshiped there regularly while attending Northwestern College. What happens to this congregation and its property is therefore of more than just passing interest.

When St. Mark's present church building was erected in 1887, today's conveniences were unknown. And though some remodeling was done a number of times, no cloakrooms, no family room, no real narthex where members and visitors could speak with one another had ever been provided. This need has now been met by a 91'x26' addition to the front of the church. The stairways from the balcony were also brought into this spacious entrance in order to guarantee a freer traffic flow.

Additions to older structures at times look anything but inviting. St. Mark's architect succeeded in making this addition appear "as if it had always been there." The original "Gothic" lines of the church were followed as closely as possible. Used "Watertown brick" was employed to match the existing structure. Stained-glass windows highlight the addition.

The church was also completely redecorated. The dominant color now is a soft blue-green. New red carpeting was laid throughout. The original solid oak pews were repaired and refinished.

Total cost of the addition and the redecorating was \$160,000. Interesting to note is that the total cost of the church and its furnishings originally was only \$23,000. St. Mark's is also still making use of its first church built in 1855. It is serving as a parish hall.

More than 2,200 worshipers attended the dedication services on May 2. Two former pastors of St. Mark's officiated in the three forenoon services. Pastor H. Wicke preached the Word and Prof. James Fricke served as liturgist. In the evening service Pastor Carl Mischke, president of the Western Wisconsin District, delivered the message. On the following Sunday a dedication song service was presented at 4:00 P.M. On May 16 a special service was held for the shut-ins at 10:30. Those on wheelchairs used a special ramp that has been provided at one of the side entrances.

Pastors of St. Mark's are Henry E. Paustian and Myron R. Kell. They join their members in thanking God for His goodness and in asking Him to use the new facilities to His glory and the salvation of all who worship there.

Christian joy, thanksgiving, and the assurance of eternal victory marked the funeral of Prof. Gustav August Westerhaus on May 22, 1971, at St. Mark's Ev. Lutheran Church, Watertown, Wisconsin. Preaching on Philippians 1:23: "For I (have) a desire to depart and to be with Christ, which is far better," Pastor H. Paustian applied his theme, "A Christian's Greatest Desire," to the departed professor and to the worshipers. "To be with Christ" was a wish often expressed by Professor Westerhaus since his retirement in 1966 after teaching at Northwestern College for 50 years. His wish was granted on Wednesday afternoon, May 19, when he quietly fell asleep in the Lord.

The sermon was preceded by the singing of Hymn 585, summarizing the faith of the departed in the words, "I thank thee, Death, thou leadest me to that true life where I would be." Also sung was Hymn 463 in which the worshipers—the family, former students, colleagues, and St. Mark's members—praised the Lord, saying, "For all the saints who from their labors rest, Thy name, O Jesus, be forever blest." A male chorus, composed of teachers, pastors, and professors, closed the service by sing-

ing: "I know that my Redeemer lives!" Pastor M. Kell read the liturgy and officiated at the committal on the Lutheran cemetery.

Northwestern College was represented by President C. Toppe who said of Professor Westerhaus that he always looked upon his calling at Northwestern with a deep sense of duty and carried it out with loyalty and faithfulness. From 1916-1966 Professor Westerhaus taught courses as varied as medieval history, religion, logic, psychology, philosophy and German.

Born in Borgholzhausen, Westphalia, Germany, 87 years ago on July 21, 1883, he came to the United States with his parents, August Westerhaus and Louise, nee Gehner, in 1891, settling in Windside, Nebraska. In 1908 he graduated from Northwestern College and in 1911 from Wisconsin Lutheran Seminary. He then served as pastor at Zion Church, Glendale, and St. Luke's Church, Elroy, Wisconsin. In 1916 he accepted the call to Northwestern.

During his years at Watertown he assisted at St. Mark's Congregation during a number of vacancies. After his retirement, he continued to assist with the preaching of German. Now he is at rest, according to our Lord's promise, "I will come again and receive you unto Myself, that where I am, ye may be also."

He is survived by his wife, the former Frieda Bruss, whom he married on June 24, 1925. Also surviving are a daughter Jeanette (Mrs. W. Wichmann), who teaches at St. John's Lutheran School, Waterloo, and three sons: Martin, professor at Wisconsin Lutheran High School in Wauwatosa, Paul, and Theodore. There are 12 grandchildren and two brothers.

As a congregation, as a College, and as a Synod we have reason to thank our God for His gift to us in the faithful services of this humble, Christian man.

We Turn to the Psalter...

... As We Review Our Worship Attitude—Psalm 15

Because of the fact that certain unchanging parts of our Lutheran liturgy are read or sung during each one of our worship services (with the danger that we may participate rather mechanically) - and because some of the Propers (which vary from one Sunday to the next) contain words or sentence structures which make them difficult to comprehend, there is increasing activity among church musicians, pastors, and students of the liturgy directed at making our entire formal worship structure more meaningful and edifying to all who worship with us in our churches. And it is important that our worship does come from the heart, for if it does not - if we merely "go through the motions" as we participate in the prayers and responses of the liturgy - we are most certainly not worshiping our Lord properly.

In the broader sense of the term. the entire life of a Christian can be called "worship." Psalm 15 lists some of the basic virtues which will be in evidence in the life of a true "worshiper." Verse 1 sets the stage: "Lord, who shall abide in Thy tabernacle? Who shall dwell in Thy holy hill?" This is as much as to say to the Lord: "Of whom, Lord, do You approve? Who are the ones who are truly in constant communion with You and Your Word? Who has the gracious privilege of being 'at home' in Your presence, not only in the outward communion of the visible church, but 'in spirit and in truth'?"

The Psalm lists some basic essentials marking the Christian's worshiplife. At the same time, by implication, we have here a warning against "sham worship" and hypocrisy. If a person

does not "walk uprightly" or "work righteously"; if he does not "speak the truth in his heart" (v. 1) — then he does not have the Christian characteristics which are acceptable to God.

Psalm 15 next lists specific examples of sins which the true worshiper will avoid with God's help, but this list is by no means complete. The Psalmist "gives examples, but does not exhaust the case." If you read verses 3 to 5 you will be reminded that the child of God will not slander nor defame his neighbor; he will avoid the company of evildoers and will enjoy the fellowship of those who "fear the Lord." ("Contemned" in v. 4 means to "treat with contempt" or to "scorn.") The child of God will be true to his word. If he swears a proper oath and then finds that it is going to be to his disadvantage to honor it, he will not go back on his word (v. 4b). Nor will he enrich himself at his poor neighbor's expense or ignore what is just and right for the sake of a bribe (v.5). Other Scripture passages reflecting these thoughts are: Exodus 22:25; Leviticus 25:36, 37; Deuteronomy 27:25; Isaiah 1:23: etc.

After completing this list of fundamental Christian virtues, the Psalmist concludes: "He that doeth these things shall never be moved." True worship of God will help the Christian to stand firmly on the position of godliness which he occupies by the grace of God. Neither temptation nor hardship will move him from that position. May God help us to conduct our worship-life in a manner which will always be pleasing to Him!

CENTENNIAL AT ELKHORN

According to Time magazine, there is a loss of the sense of history in America. Younger people are simply not interested in the experiences of older people. The events of 1971, the centennial year at First Evangelical Lutheran Church of Elkhorn, will change this for our members..

On February 7, the congregation held a centennial fellowship dinner. The format of the TV program "This is Your Life" was used to make the church history memorable. A model of our present, 86-year-old church had been constructed by a member family, Mr. and Mrs. Wallace Pontel. Complete with lighted cross and stained-glass windows, it occupied the center of the stage. Members in costumes of years gone by acted out interesting episodes in the church's history. Luther's Choraliers, our youth choir, even sang a number, "Still, Still," in German. A pictorial centennial booklet was given to each of the member families attending.

The evening's accent, however, was not completely on the past. A talk, illustrated with colored slides, was given by the architect chosen to plan the church's new plant on a four-acre site already acquired. At the close of the program, tours were given of the very fine new facilities of a nearby church where the banquet and program were held.

On February 21, "100 Years of Service to God's People" was marked at the two Sunday morning services. Pastor Norman Berg, Executive Secretary of Home Missions of our Synod, preached on the theme "It Is Still The Same." Between services, Pastor Berg was able to watch the half-hour Lutheran Guideposts TV program on which he was one of a panel discussing "Why Build Churches."

On May 2, the first of four confirmand reunions was held. Men and women confirmed or married by Pas-

tor Walter Reinemann between the years 1920-1934 had been invited to the service and reunion dinner. Martin Reinemann of DeKalb, Illinois, brought his 82-year-old father from Oconomowoc to make the day especially memorable for all of us. When, during the 10:15 service, those baptized, confirmed or married by Pastor Reinemann were asked to rise, over half of the congregation did so. At the reunion dinner, prepared by the Ladies' Aid, confirmands were seated by classes. Each was asked to tell something about his family, work and present home. Cross candlesticks, made by three men of the congregation, Lawrence Kehl, George Brellenthin, and Helmuth Huebner, as commemorative pieces for each family in the church, were also presented to Pastor Reinemann and his son and to the two couples who had come the farthest distance for the reunion, from the states of New York and Illi-

During the last 50 years of First Lutheran's history, two other pastors also served for longer periods of time. A reunion will be held on July 11 for those confirmed by Pastor Herbert Lau from 1951-1967. His widow will be present, and one of his confirmands, Pastor John Huebner of Dexter, Michigan, will preach the sermon. In September, those confirmed by Pastor Walter Diehl from 1934-1950 will be invited back. Pastor Diehl, now of Dallas, Texas, will preach. The fourth celebration will include those confirmed by Pastor Gevers from 1891-1920, and those who have come to our congregation by transfer or affirmation of faith.

At the same time, during this centennial year, work continues on the design and planning of new facilities to serve our people better in the next 100 years. May the Lord bless us as graciously in the future as He has in the past!

Good News from Fond du Lac

Members of the Winnebago Lutheran Academy Association and patrons, faculty, and students are pleased to announce that a new addition is being added to the

present building which was built about 15 years ago. The cost of the new facility, completely furnished, will be about \$300,000. Cramped quarters, as a result of larger classes in recent years, made the addition necessary. Present enrollment at Winnebago Lutheran Academy is 300.

The additional 16,000 square feet will provide eight teaching stations, plus additional administrative and guidance quarters. Also planned is a large music rehearsal area, with individual practice rooms. A research center, a new science laboratory, a combination study hall-classroom, and a commons area are included.

The addition will be fitted into an area on the west end and northwest corner of the present building. Its exterior will be of block and brick. The building will be air-conditioned. It will be without windows.

Engaged as architects was the firm of Sauter, Seaborne, Paynter, Duszak Ltd., of Appleton. Time of construction is estimated at five months, the completion date sometime in November.

The principal of Winnebago Lutheran Academy is Prof. T. W. Zuberbier. Pastor Martin Janke is chairman of the Academy Board. Members of the building committee are Mr. Vincent Huth, chairman, Pastor G. J. Ehlert, secretary, Prof. Zuberbier, and Prof. Walter Otterstatter.

Southeastern Wisconsin

Wisconsin Lutheran High School - Project "E"

The Wisconsin Lutheran High School Conference, comprised of 50 Wisconsin Synod congregations in the Milwaukee area, through its chairman, Pastor K. Otto, recently announced the decision to undertake a major

capital fund-raising campaign called Project "E." Purpose of the appeal is threefold: education excellence; elimination of debt; and expansion. The minimum need established is \$1,100,000 - \$1,500,000.

For 16 years WLHS has experienced an annual enrollment increase. At present, a student body of 1,100 is housed in an overcrowded facility that will soon be asked to accommodate 1,250 - a most healthy dilemma.

Serving as campaign leaders are Mr. Ray G. Tiegs, honorary chairman, and Pastor Robert J. Voss, general campaign chairman. Mr. Tiegs, a past president of the Wisconsin Marine Bank, has been a member of the banking profession for 52 years. He has been a member of the Wisconsin Lutheran High School Board and of the Board of Trustees of the Synod. Pastor Voss is the Executive Secretary of the Commission on Higher Education of the Wisconsin Ev. Lutheran Synod. Prior to this he served as president of the Wisconsin Lutheran College, since merged with DMLC.

The campaign will embrace a comprehensive program to acquaint all congregations with every phase of the appeal. Scheduled for June 24 is the General Inaugural Meeting. June 27 is General Solicitation Sunday. It is expected that 30,000 communicants will participate.

One of the unique aspects of the campaign is a Mini-Campaign conducted by the high-school students among themselves. They will seek to raise a minimum amount of \$50,000. The student drive was kicked off in a pep rally on Tuesday, May 18.

The expansion being planned includes a "junior gym," music-room facilities, and five additional classrooms. This will meet only the present needs.

Western Wisconsin

"United to Serve Jesus" - this motto of the Lutheran Women's Missionary Society has also been the motto of the ladies of the Southwest Wisconsin circuit for the past 10 years. The circuit met for the first time on May 19, 1961, at St. Paul's Ev. Lutheran Church of Tomah. The anniversary meeting, observing one decade

Displayed in the church were posters giving a pictorial history of the circuit, noting the date and place of each meeting and the mission effort supported. Flags which fly over WELS missions were arranged at the front of the church.

Main speaker for the day was the Rev. Conrad Frey, president of Dr. Martin Luther College. His subject was: "The Scope of our Synod's Christian Education Program." His words were received with rapt attention since there are Christian day schools in the following congregations represented in this circuit: Barre Mills, West Salem, Bangor, Sparta, Tomah, Wonewoc, and Baraboo.

Plans were made to attend the national convention in Beaver Dam. Among the new mission programs adopted is the Apache Nursery at East Fork, Arizona. Aid was also voted to the language-study program provided for the wives of world missionaries. The circuit will meet again in the fall at Bangor, Wisconsin.

THE FORTY-FIRST BIENNIAL CONVENTION OF THE WISCONSIN EVANGELICAL LUTHERAN SYNOD
