

# The 1960's:

A Decade of Growth and Change  
For Calvary Evangelical Lutheran  
Church, Thiensville, WI

The decade of the 1960's was a time of growth and change for Calvary Lutheran Church in Thiensville, Wisconsin. In the 1960's, Calvary saw tremendous growth in its annual operating budget, in the size of its facilities and in its membership. There was also a change in staff. During this time period, Calvary was lead by two different pastors and by two different principals. The details of this growth and change are found within the minutes of the voters' meeting of Calvary Lutheran Church which are appended, and are summarized here.

## I. THE BUDGET GROWS

In 1962, Calvary had an operating budget of \$21,197.50 not including a pledge to the Wisconsin Evangelical Lutheran Synod (WELS) of \$4,230.00.<sup>1</sup> This pledge to the WELS was around 19% of their annual operating budget. In 1970 however, Calvary's budget for home purposes had jumped to \$35,826.00<sup>2</sup> and its pledge to the WELS was that of \$15,364.00.<sup>3</sup> Not only had its annual operating budget increased 60% but also its mission pledge to the WELS had increased to 43% of its annual operating budget.

Naturally some of this growth was due to inflation and some was due to the increase in membership. However it's easy to see that God's gracious hand was upon Calvary and that their hearts were pouring out gifts of love to him. One also wonders if the congregation at Calvary didn't have a special place in its heart for WELS missions, making their pledge to it a priority, seeing as it was a one-time WELS mission itself. The table on the following page serves as a reference guide to the growth of both Calvary's operating budget and its mission pledge to the WELS.

## II. THE MEMBERSHIP GROWS

The minutes for the decade of the 1960's only mention membership totals four times, two times of which are in the same year, throughout the ten years recorded. However they do show a tremendous growth rate for Calvary. In 1964 there were 382<sup>4</sup> souls on the records with that number increasing to 568<sup>5</sup> in the year 1969. It appears that most of this growth took place under Pastor Lindloff. There could be a few reasons to explain this.

Without thorough documentation, it's difficult to tell what type of outreach Calvary was doing, if any. However it seems as if more students from Wisconsin Lutheran Seminary (WLS) were transferring their memberships to Calvary in the latter part of the decade under Pastor Lindloff than they were in the earlier years under Pastor Tabbert. This could explain some of its growth. Also there were many transfers coming into Calvary under Pastor Lindloff through a profession of faith. This seems to indicate that of those new members, there may have been many that were dissatisfied Lutheran Church Missouri Synod (LCMS) members. This would make sense in lieu of the recent break of fellowship between the WELS and the LCMS.

These reasons however do not overlook the ultimate reason and cause of the growth at Calvary, God's gracious hand. Again we see God showering blessing upon his Church and especially upon Calvary. Regardless of the outward reasons and methods used, we can be sure that this growth took place only because the head of the church, Jesus Christ, wanted and caused it to happen.

Following is a chart showing the membership growth of Calvary throughout the decade of the 1960's.

### III. THE FACILITIES GROW

Along with the growth in Calvary's budget and membership, the decade of the 1960's brought about a change in the facilities and the property owned by Calvary. Within those ten years, the members of Calvary built a new school building and a new all-purpose room. They also purchased a new teacherage<sup>6</sup> and additional land<sup>7</sup> adjacent to the lot they were presently occupying.

Originally Calvary had wanted to build a new school and an all-purpose room all at once but finances were a hindrance to this desire. Even with doing some work themselves, the total package would have cost the congregation an estimated \$138,500.00<sup>8</sup>. This being the case, they chose to build just the four classrooms for an estimated \$93,000.00, leaving the all-purpose room to be considered at the "earliest possible moment."<sup>9</sup>

This \$93,000.00 may have seemed like a bargain compared to the \$119,841.50<sup>10</sup> it could have cost them if they didn't do much of the work themselves but it was still a \$93,000.00 project. And this was for a church whose annual budget at this time was only about a fifth of the project's price. Expensive or not, construction was underway by the middle of the summer 1961<sup>11</sup> and by October it looked as if they would be able to secure all the loans needed for the all-purpose room from within the congregation itself.<sup>12</sup> On Sunday, February 25, 1962, the eagerly anticipated dedication day arrived.<sup>13</sup>

Some five years later, in 1967, the congregation undertook the task of finally having the all-purpose room added on, breaking ground in April.<sup>14</sup> This task would cost them somewhere in the

neighborhood of another \$95,000.00.<sup>15</sup> Again, the congregation was called upon to help with the cost and the individual members were there to offer their assistance. Many gave financial gifts and others generously loaned <sup>l e n t</sup> money to the congregation at low interest rates so that the costs could be covered.<sup>16</sup> By late 1967, the construction was nearly finished with only the finer details left to complete.<sup>17</sup> Oh how the Lord had blessed Calvary in all things!

#### IV. CHANGE IN STAFF

The decade of the 1960's was a great time for all aspects of growth in the history of Calvary but not everything worked out as well as their building projects. Calvary had problems obtaining and maintaining their lower grades, female teachers. Staff changes were occurring all the time. In fact, there were so many changes in the staff that the voters didn't feel it necessary to have call meetings every time there was a need. They rather gave the School Board and/or the Church Council the authority to call on their behalf. This is why it is impossible to tell from the voters' meeting minutes exactly how many times the congregation issued calls for teachers.

The reason for so many changes is not clearly documented but it appears that many of the lady teachers were married either to WLS students or WLS professors. Therefore one reason for so many changes may have been that when there was a change in their husband's ministry that required relocation, Calvary lost a teacher. This was the case with Mrs. Bruss.<sup>18</sup> Another reason may have been that single lady teachers eventually became engaged and resigned due to their impending marriage, as was the case with Miss Baetsch (sp?)<sup>19, 20</sup>

Not only did Calvary extend many divine calls during the 1960's; called workers at Calvary also received many divine calls. Both Pastor Tabbert and Mr. Jenswold were talented men and their gifts were recognized throughout the WELS. The large number of congregations that felt the God-given skills of these men would benefit their congregational needs shows this. Truly the Lord gave both men many opportunities to evaluate their ministry.

From 1962 to 1966, documentation of the voters' meeting minutes shows that Pastor Tabbert received six divine calls to other congregations and at one point in 1962 he was holding three calls at one time.<sup>21</sup> The congregation at Thiensville loved their pastor but they also recognized their need for the gifts God had given him. In February 1964, Pastor Tabbert asked for a peaceful release from his call so that he could accept a call to start a mission at Flossmoor, IL.<sup>22</sup> However the congregation asked him to reconsider his decision before they would grant him a release and Pastor Tabbert eventually returned the call.<sup>23</sup>

Pastor Tabbert eventually accepted a call in July 1966 to Gethsemane Lutheran Church in Milwaukee, WI.<sup>24</sup> The congregation of Calvary immediately began calling for a new pastor and on their second issuing of a divine call, Pastor L.J. Lindloff wrote a letter to Calvary in October 1966 announcing his acceptance of it.<sup>25</sup>

Mr. Jenswold's situation was much the same as that of Pastor Tabbert. As principal of Calvary, he too asked the congregation for a peaceful release from his call so as to accept another call to St. Peter's Lutheran School in Fond du Lac, WI.<sup>26</sup> The congregation responded much the same as in the similar situation with Pastor Tabbert. They urged him to reconsider his decision and he eventually returned the call on a later date. From 1962 to 1968, Mr. Jenswold received a total of

twelve documented calls from sister congregations, the last of which he accepted to St. Mark's Watertown, WI.<sup>27</sup>

Calling a new principal didn't go quite as smoothly for Calvary as calling a new pastor did. There were at least five calls extended to men for the position of principal before an acceptance occurred. (This number may be higher depending on how many divine calls were issued by the Church Council.<sup>28</sup>) The school, therefore, had to run without a full time principal during the 1968-69 school year with Miss Carol Hedrick, assigned by Dr. Martin Luther College, covering the 7<sup>th</sup> and 8<sup>th</sup> grades for the year.<sup>29</sup> In January 1969 however, Calvary issued a divine call to Mr. Arnold Nommensen to be the principal of their Lutheran school.<sup>30</sup> Mr. Nommensen accepted their call and arrived in the summer of that same year.<sup>31</sup> Calvary now had a new principal to close out the decade of the 1960's and to begin the decade of the 1970's

Truly God was watching over his flock at Calvary in Thiensville, WI. The abundance of his blessings upon this congregation is overwhelming. Not only did he bless Calvary financially and numerically, but he also gave them the most important gift any congregation could want, faithful servants true to his Word. When a pastor left, another, just as faithful to the Word, stepped in. When the principal left, another principal came to watch over the Christian education of the Calvary's youth. Calvary's history during the 1960's is another wonderful example of our Savior's grace and love as the head of the Church.

## Meeting called by the Building Committee- June 8, 1961

- ◆ 29 members were present.
- ◆ It was reported that the lowest estimate for four classrooms and the all-purpose room was \$172,787.44. For the four classrooms only \$119,841.50.
- ◆ With some deletions and doing our own contracting, it could be done for about \$93,000 for the four classrooms.
- ◆ Under these same conditions a rough estimate for the four classrooms and all-purpose room would be \$138,500.
- ◆ The committee recommended to construct the four rooms only.
- ◆ It would be necessary to borrow about \$45,000 for the project. \$25,000 could be had by loans inside the congregation at 4.5 % and \$20,000 by outer loans at 6%. Total interest could amount to about \$7,100.
- ◆ It was moved and passed to go ahead with the construction of the four classrooms and that the all-purpose room be considered at the earliest possible moment.

- ◆ The Thoreau (sp?) school building is rented for the entire year.
- ◆ There will be a higher book rental fee charged next year.
- ◆ Two men have volunteered to take care of the athletic program.
- ◆ 110 new student desks and 3 teachers desks will be purchased.

**BUILDING COMMITTEE'S REPORT:** The building is progressing so it will be closed in for the winter. Lighting is being selected. Costwise we are holding the line. Mr. Mewes, Mr. Schiessel, Mr. Lueders and Mr. Geugles (sp?) are putting in much of their time on the building. Pastor is also acting as a part time general contractor. We have an efficient and hard working Building Committee.

**STEWARDSHIP COMMITTEE'S REPORT:** The Stewardship Committee is engaged in preparing a dedication booklet.

**NEW SCHOOL FINANCE COMMITTEE'S REPORT:** Letters for loans have been sent and answers received. We should be able to borrow enough within our congregation.

- ◆ It was passed to authorize the trustees to issue notes paying interest 4.5% per annum plus 1.5% covering any interest loss sustained by members making loans if they are called in before bank interest dates and that interest and principal payments be dated December 1 and June 1.

**WLHS REPORT:** Enrollment now is 748. They are still using money for debt retirement to operate. They are paying \$67,000 interest on the loan per year. The debt is \$55,000 greater than last year. Some congregations will discontinue payments for debt retirement unless present practice of using this money for operating expense is stopped.

- ◆ Mr. and Mrs. Peter La Flex (sp?) had to be dropped from membership.
- ◆ It was passed to have a basket collection at the door for the Church Extension Fund, Synod Committee for Relief, and the Seminary Kitchen one Sunday a month during the next three months at the discretion of the Pastor.
- ◆ The motion passed that Calvary Lutheran Church will not grant transfers to Missouri Lutheran Churches in accordance with the Synod resolution.
- ◆ The meeting closed with the Lord's Prayer.
